TTP18/004 Train Service - To Receive Updates

Jon Heal provided an update on train services in Stone.

Trains resumed at Stone on 14 December 2008 after a gap of nearly five years. This has successfully put the town on the national transport map. People now have easy access for both work and leisure facilities in the town.

The Department for Transport should announce in June who will run the franchise (under West Midlands Rail, supported by Staffordshire County Council and other councils) for the next few years. The contenders are Govia/London Midland or Abellis. The service calling at Stone will change in December 2018 (it will be direct to Birmingham, requiring a train change for Euston). North staffs Rail Promotion Group (NSRPG) will be talking to the franchisee when known.

Community Rail is now a compulsory part of rail franchises. London Midland are now actively involved and details of two officers able to provide support in respect of Stone Station were given. The train service updates were noted.

TTP18/005 Stone Town Trail - To Consider the draft wording for the latest edition

The Committee considered the wording of the latest edition of the Stone Town Trail.

RECOMMENDED: To accept the wording of the Stone Town Trail leaflet.

TTP18/006 Visit Staffordshire - To Consider whether to re-subscribe to the Service

The committee considered the benefits of Visit Staffordshire and whether the Town Council should re-subscribe. It was suggested it might provide an opportunity within the wider strategy to promote the town.

Purpose of Grant:To support the financial viability of The Hub during its journey to self-sufficiencyAmount Awarded:£6,000 @ £500pm (£4,500 received to date)Dates of Award:June 2016 – May 2017

The Hub has a running cost of around £36,000 per annum. This is generated from Grants, Donations and Fundraising Events. The STC Grant therefore covers a substantial 17% of total costs.

How the Grant has been used:

- Creation of a more attractive venue to encourage attendance
- Expansion of the services to a wider section of our community
- Provision of a new Youth Club
- Support of overheads including 2 part time staff

The Hub is dedicated to improving the lives of residents of Stone and surrounding villages by providing support and advice in times of need. Our activities are a life-line for many. Our motto "Making Lives Better" sums up our Objectives.

Our Support is provided in 3 main areas:

(1) Reducing Poverty and its Effects: (Advice Centre, Job Club, Family Law Clinic, Money Advice and Budgeting, Food Parcels)

(2) Combating Social Isolation:

(Drop-in Centre, Knit and Natter, Crafting, Breast-feeding Support Group)

(3) Encouraging Youth Interaction:

(Stone Youth Cafe, Youth Activities, Volunteering Opportunities)

Making Lives Better Our activities are overseen by a Board of Trustees who meet monthly or more often when required to do so.

Day to day operation is carried out by the part time centre manager and another part time member of staff. They are supported by volunteers.

The Hub has also benefited from the input of a STC Liaison Group that meets quarterly and comprises Councillors, Trustees and the Centre Manager.

How has the work done impacted the local community?



The Hub has considerable reach within our community across age ranges and both sexes.

The Hub is gaining a strong reputation within the community for providing practical interventions and facilitating access to specialist organisations.

We are becoming a focal point for the provision of advice and support and were recently asked to host a local mental health /wellbeing event.

Will Our Work Continue After The Grant Ceases?

At the start of the last year, the Charity had only £7,000 in the bank, enough to support less than 3 months activity. Our current balance has risen to around £21,000 enough to support around 7 months, however, our main fundraising events for the year have been completed and we will be supporting our activity from our balances for the coming months.

We have not yet reached our goal of creating a reserves buffer to tide us over unexpected setbacks and so the loss of a £6,000 grant will certainly be keenly felt. We will need to continue to tightly control overheads and will seek other grants (though we are aware that small charities are finding grants increasingly difficult to come by).

Summary

Trustees and Management are exceptionally grateful to Stone Town Council for its wholehearted support over the last year. Without the Grant we may not have found our way through the 12 months and we would certainly not be in a relatively sound position financially.

Our continuing relationship with Stone Town Council has also enabled us to demonstrate our reputation to other Grant providers and most probably helped us to obtain other financial support.

We have not yet the confidence to claim self-sufficiency but we are certainly moving towards that goal.
