Dear Mr Trigg,

Thank you for your letter concerning proposed changes to West Midlands Trains' services between Staffordshire and the capital.

From December 2018 we will be providing rail users across the county with three direct services to London as well as a host of extra journey opportunities.

Starting with the current Crewe- Stoke- Euston service, from December this will run direct between Crewe and Stafford. This will allow us to run longer trains (more carriages) to meet growing demand. Unfortunately, the track layout, signalling and platform lengths via Stoke -on-Trent prevent us from running via this route with more than the existing four carriages.

We will still be providing a direct service from the Potteries to London. From December 2018 we are introducing a Crewe-Stoke- Birmingham – Euston service. In addition to keeping a direct service to the capital, the train will also call at Birmingham International, giving the Potteries a direct service to the airport.

For those who want a quicker journey, while still benefitting from London Northwestern Railway's low fares, we will be providing a connecting service at Stafford. These connections will be between 5-15 minutes in each direction.

On the matter of fare prices, season tickets and 'anytime' tickets are regulated by the Department for Transport. These prices are reviewed once per year and adjusted in line with Government policy. Our cheaper, promotional, fares are monitored and set by West Midlands Trains according to demand.

As part of the changes planned for December Staffordshire rail users will also benefit from a new Liverpool – Birmingham – Euston service calling at Stafford and a new Rugeley Trent Valley – Birmingham- Euston service via Walsall. Both services will also call at Birmingham International.

In order to operate new services, all train companies have to make their bids for timetable slots next month. Once the relevant industry processes have been completed, we hope to have confirmation of the December timetable in late June / early July.
