#### 14. Members' Motions under Standing Order 4

#### **Councillor Mrs Jill Hood**

'Once again I raise serious concerns by members of the public regarding vehicles using Stone High Street after 4pm. The High Street has become a rat-run for vehicles travelling down at high speed trying to beat the traffic queues on Christchurch Way. There are also a large number of vehicles after 4pm parked in such a way that pedestrians are forced in to the path of moving cars. Signs on the High Street quite clearly state PEDESTRIAN ZONE NO VEHICLES 10 am to 4pm EXCEPT FOR PERMIT HOLDERS. MIDNIGHT 10am-4pm EXCEPT FOR ACESS AT ANY TIME. Which allows for traders to arrange delivery and access, to their premises.

There are motorists ignorant of the traffic regulations imposed on Stone High Street who think they are entitled to use the High Street after 4pm to drive down and park. Pedestrians lives are at risk, we have a large elderly population who enjoy using the High Street some who may be slow moving and hard of hearing and are not expecting to encounter a speeding car. There is also a children's nursery in the middle of the High Street.

Stone Town Council has debated the issue on many occasions with nothing resolved to protect our residents and visitors in Stone High Street. It is time responsibility was taken to make sure that all those who are responsible for preventing unauthorised vehicles from entering the High Street carry out their legal duty in making sure the law is applied and all relevant signage clear and understandable.

I recommend that we invite the County and Borough Councils to join Stone Town Council in setting up a joint working group to deal with this issue and make sure that the High Street is safe for everyone.'

## Proposed Oneway Traffic Management Changes – Church Street, Stone

Staffordshire County Council is proposing to install a new Oneway traffic management system within Church Street, Stone. This is with the view to improve road safety, on street parking and allow local businesses to operate more effectively.

After undertaking an initial consultation an amended design has been completed where it is the proposal to turn Church Street Oneway from its junction with B5027 Lichfield Road in a north easterly direction to its junction Redhill Road and then retain the two-way traffic flow from its junction with Redhill Road in a south easterly direction to its junction with B5027 Lichfield.

New illuminated signage will be installed at the commencement and termination of the Oneway system to inform traffic of the restrictions. Also, a new island will be built prior to the right turn of Church Street, to discourage traffic exiting Redhill Road from driving ahead into Church Street.

Any existing signage in Church Street facing the wrong direction of travel will be removed, in particular signage relating to overhead power lines.

All the above proposals are indicated within the attached drawing: D6689T/34/R01/01.

I would like to ask for your views in relation to the proposed changes; therefore, can you please complete and return the attached form within 21 days of the date of this letter.



As I'm sure you will be aware, Persimmon Homes have gained planning for the housing development north of Eccleshall Road. As part of the development, we are looking to get the roads and sewers adopted, by Staffordshire County Council and Severn Trent Water respectively.

Staffordshire County Council have advised that they do not wish to take ownership of the SUDS ponds and two areas of woodland on the site. To ensure that the area is not kept unmanaged we are proposing to set up a management company for the areas the county council do not wish to adopt. The attached plan shows the pond area we are proposing to put into the management company.

Dear Parents,

Following discussions with the Local Authority and the Governing Body of Manor Hill First School we are now writing to inform you of the proposal to increase the capacity of Manor Hill First School.

As you may be aware, there are a number of housing developments within the catchment area of the school and it is expected that demand for school places will increase.

The expansion is necessary due to the projected increase in demand for first school places within the local area as a result of the new housing development. The expansion would provide additional accommodation to increase the capacity of the school by a further 125 places. This would increase the published admission number (PAN) of the school by 25 places each academic year.

It is anticipated that the project to provide the additional accommodation would be complete by the beginning of the academic year September 2020.

The school cannot accommodate this increase in school places within its current layout and therefore internal remodelling work is necessary to ensure that there is the correct number of general teaching rooms for the proposed size of the school.

The expansion would bring the following benefits to the school:

- The creation of an additional general teaching space from existing accommodation.
- Remodelling of the existing ICT room for use as a general teaching space
- Provision of portable ICT facilities
- Creation of a library space
- Improved reception/entrance to the school
- Remodelling/refurbishment across the building to reflect and enable the overall adjustments necessary
- Replacement of girls' toilet
- Creation of additional boys' and accessible toilet facilities
- Improved outdoor recreational facilities
- Additional staff car parking spaces

It is intended that from September 2019 the school will provide up to a total of 30 Reception places, instead of the current 20 places available. With the school providing up to a total of 45 Reception places in future years.

As part of these proposed changes there will be a 4 week consultation with the Manor Hill First community and the wider Stone area to hear the views of local people. This will provide the opportunity for you to read about the proposed changes, attend a consultation meeting to see the plans for the school's development on 4<sup>th</sup> October 2018 between 4.30pm and 5.30pm at Manor Hill First School.

## STATUTORY CONSULTATION DOCUMENT

## PURPOSE OF THE CONSULTATION

- 1. Staffordshire County Council is responsible for ensuring that there are sufficient school places in the county. They have been in discussion with the school over the last two years, as part of a strategy to increase first school capacity as a result of housing development.
- 2. The Governing Body of Manor Hill First School wants to hear the views of local families, local community, school staff, governors and parents and other bodies on the proposal to:
  - Enlarge Manor Hill First School.
  - To consult, as part of the annual process, on an increased number of Reception places available at the school from 20 to 30 by September 2019.
  - To increase the number of Reception places available at the school from 30 to 45 by September 2021, this will be conducted as part of the annual consultation process on admission arrangements.
  - Increase pupil numbers over time by providing a total of 225 places an increase of 125 places.
- 3. It is important that you make your views known by 3:30pm on 19<sup>th</sup> October 2018.

### WHY ARE MORE SCHOOL PLACES NEEDED?

- 4. The County Council is committed to providing the best possible start for young people, which means ensuring that every child who needs a school place in their area has one available.
- 5. The proposal to expand Manor Hill is to meet projected increased demand for school places, as a result of local housing developments at Walton Hill House Farm for 500 dwellings, adjacent to the school, and also the Common Lane and Eccleshall Road development for 94 dwellings, which is also within the catchment area of the school.
- 6. The increase of 594 dwellings once completed would be expected to generate around 18 pupils per year group.
- 7. The proposal would enable the school to increase its Published Admission Number (PAN) from 20 to 45, over a number of years increasing its total capacity by 125 places.
- 8. As not all of the pupils would be generated immediately, it is proposed that the school increases its admission number in increments, firstly to become a one

form entry school, admitting up to 30 pupils with a capacity of 150 places. Then in subsequent years admitting up to 45 pupils to become a  $1\frac{1}{2}$  FE first school with a capacity of 225.

- 9. The enlargement would mean that initially up to 10 more Reception places would be available for children starting full-time education at Manor Hill First in September 2019, A further 15 places Reception places would be available in future years.
- 10. The additional places at the school will ensure that the school has capacity to accommodate pupils that are expected from the known housing developments.

## MANOR HILL FIRST SCHOOL

- 11. Manor Hill is a school growing in popularity in Stone. It was inspected by OFSTED in October 2017 and assessed as a "good" school.
- 12. The current Published Admission Number (PAN) is the number of Reception places offered to children starting their full-time education. Manor Hill First school currently has a PAN of 20.
- 13. The Governing Body are committed to providing a place for all pupils in their area who wish to attend the school but cannot accommodate the increase in school places within its current layout. Therefore internal remodelling work is necessary to ensure the correct number of general teaching rooms for the proposed size of the school.
- 14. The school will exceed its current admission number to accommodate pupils from the local housing developments.
- 15. The Governing Body intend to consult on an increased admission number of 30 for the September 2019 intake. This will enable to school to continue teaching as they do currently.
- 16. Working with the school admission and school organisation teams the Governing Body will determine the most appropriate academic year to formally increase its admission number from 30 to 45. This would see the school moving towards more mixed aged teaching.
- 17. It should be noted that the additional places are being provided to accommodate pupils from the new local housing developments within the school catchment and not to draw pupils away from other local schools in Stone.
- 18. Staffordshire County Council is fully supportive of the proposal as it would provide more places for local children. The additional number of pupils will also generate additional funding to enable the appointment of more teachers and teaching assistants.

## HOW WOULD THE SCHOOL BE IMPROVED?

- 19. The school cannot accommodate the proposed increase in school places within its current layout and therefore building work is necessary to ensure the correct number of general teaching rooms for the proposed size of the school.
- 20. The expansion would bring the following benefits to the school:
  - The creation of an additional general teaching space from existing accommodation.
  - Remodelling of the existing ICT room for use as a general teaching space
  - Provision of portable ICT facilities
  - Creation of a library space
  - Improved reception/entrance to the school
  - Remodelling/refurbishment across the building to reflect and enable the overall adjustments necessary
  - Replacement of girls' toilet
  - Creation of additional boys' and accessible toilet facilities
  - Improved outdoor recreational facilities
  - Additional staff car parking spaces
- 21. The work to ensure there is sufficient accommodation will be funded by developer contributions secured from the two local housing developments one of which is also to provide additional playing field facilities.
- 22. It is anticipated that work would start during the spring term in 2019, with a view to the additional places being available for the September 2020 intake. The school and contractors would work together to minimise any disruption during the build process.

## HOW WILL THE SCHOOL GROW?

- 23. The school will consult on an increased PAN of 30, for September 2019 which would provide an additional 10 places for our Reception intake. Consideration will also be given to providing additional places within other year groups based on demand, up to 30 for each year group.
- 24. We will work with the School Admissions and School Organisation Teams of Staffordshire County Council to determine when the PAN will increase to 45 this is currently considered to be for September 2021.
- 25. Consideration will also be given at this time to provide additional places within other year groups based on demand, up to 45 for each year group.

## HOW WILL IT AFFECT THE CHILDREN IN SCHOOL?

- 26. Pupils currently at the school would not be affected and would stay until they move to middle school.
- 27. The proposed changes would be implemented gradually for children starting at the school in Reception, with no substantial changes to the way in which children are currently taught.
- 28. There will be a requirement to move to more mixed aged teaching as a result of these changes as the larger intakes from the proposed increased PAN of 45 moves through the school.
