Representatives of Stone Railhead Crisis Group (SRCG) delivered a presentation on the work of the Group in relation to the building of Phase 2a of the high speed rail line (Birmingham to Manchester via Crewe) located to the west of Stone. HS2 Ltd Is proposing to site a major Railhead facility between HS2 and the M6, covering a large area of land running parallel for 2 miles between Stafford Services and ½ mile north of Yarnfield Lane.

The key themes of the House of Commons Select Committee hearing on 25 April 2018 which considered the Aldersey's Rough alternative to the Stone Infrastructure Maintenance Base-Railhead, and the decision to reject the proposal, were explained.

A summary of the Group's second appearance in the Select Committee (on 16 July) was also explained together with the Groups ongoing work to demonstrate the reasons the proposal to construct the Railhead/IMB-R will be unachievable and how the Group will be working with technical experts and national politicians in the future.

At the end of the presentation the three representatives were thanked for their attendance at the meeting.

The representatives also thanked Stone Town Council for its support.
